- These securities are held by Massachusetts Capital Resource Company. The reporting person serves as a senior vice president of Massachusetts Capital Resource Company, and may be deemed to have shared voting power over these securities. - The option granted at the exercise price of \$2.32, representing a right to purchase 8,000 shares, became exercisable in four equal installments beginning on the third anniversary of the grant date, provided the optionee remained a director. The option became fully exercisable on August 14, 2003 upon the occurrence of a change in control as defined under the terms of the option plan, as amended.
- The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$24.8278 to \$24.95, inclusive.
