As announced on November 9, 2006, in the course of preparing our financial statements for the three months ended September 30, 2006 and completing our quarterly report on Form 10-Q for that period, we identified, with respect to the fiscal year ended June 30, 2006, (1) an error in the accounting for stockbased compensation due to a calculation error associated with estimated forfeiture rates upon the adoption of Statement of Financial Accounting Standards No. 123(R), Share-Based Payment, as of July 1, 2005, and (2) an error in the accounting for revenues. In order to correct these errors, we will restate our financial statements for the fiscal year ended June 30, 2006 to reflect (a) additional stock-based compensation expense of approximately \$1.4 million and (b) additional revenues of approximately \$0.3 million. In light of the foregoing, we announced on November 9, 2006 that our previously issued financial statements for the fiscal year ended June 30, 2006 and the accompanying report of our independent registered public accounting firm should not be relied upon.

Furthermore, for the three months ended September 30, 2006, our stock-based compensation expense will be approximately \$1.4 million less, and our revenues will be approximately \$0.3 million less, than reflected in a press release we issued on November 7, 2006 with respect to our operating results for the three-month period.
