#### Item 1. Security and Issuer

This statement on Amendment No. 6 to Schedule 13D ("Amendment No. 6") relates to the Reporting Persons' beneficial ownership interest in the Common Stock, par value \$0.10 per share, of Aspen Technology, Inc., a Delaware corporation (the "Corporation").
